Discuss Letter from State Fire Marshal - Revoking Sprinkler Inspections -

Knute Sandahl, State Fire Marshal sent a letter to the district revoking our ability to conduct Fire Sprinkler Plan Reviews for commercial properties. All commercial sprinkler plans must go through his office until we have an employee that the State Fire Marshal feels confident can complete our reviews in the future.

Knute Sandahl also indicated that the previous Fire Chief has kicked his staff off the scene of an incident after they were invited to conduct an investigation. He hopes that we can build a better relationship with his office. They are only there to help when invited.

Questions and Concerns from the Budget Committee -

- 1. Will the remodel take place in 2021 or 2022? The Board indicated taking the cost out of 2021.
- 2. Does the Board want to purchase or lease equipment? The Board indicated that they are okay with leasing, but would like to see the options for both.
- 3. Remodel of Build Station 2? The board has not decided what direction yet. Commissioner Smith indicated there is a Developer who might help with the building of the next station on the south side of the tracks. He will invite him to the next board meeting.
- 4. Part-time Removal The board indicated they would like to remove the part-time program.
