**Financial Reports Presented by Hinkle:** Comm. Engelhardt-Vogel moved to accept the financial reports and report of fund investments, and to approve disbursement of funds in the amount of \$150,529.29 for the District for payment of bills and payroll as presented and approval of \$590.72 for the Association for payment of bills. Comm. Smith seconded the motion. The motion passed with a unanimous voice vote.

Palmer reported the JUB Engineering approached the Chief about offering their services to help with the levy. Chief Palmer provided JUB with our outline and JUB plans on attending the next meeting with a proposal of things we might be able to do different this time around.

#### **Old Business:**

**State Fire Commissioners Report:** Krystal Hinkle reported the association is offering an AD&D policy to its member districts. The policy would cover each employee/volunteer for \$25,000.00 24/7 coverage and \$50,000.00 for line of duty with a premium of only \$30 a year per employee/volunteer.

Ada County City EMS System (ACCESS) Update: Comm. Beatty reported they will be meeting next Thursday.

**Station 2 Property:** Chief Palmer reported that it was taken to City Council and it was approved for the lot split. Those documents were given to the owners and they will record it with the county. Once the owners go through the proper steps, we can then tender the remaining funds to purchase the property. Attorney William Gigray recommended that we should file for a recommendation for a zone change to public. Chief Palmer stated once the recording happens, he will get it on the agenda with the city and get the zoning changed.

**Lexipol Online Policy Code:** Chief Palmer truly feels this would bring a cohesiveness with the other fire district in the treasure valley. The board requested a firm price, a sample policy, a plan on how the implementation will work so it doesn't sit there and money was wasted and information on how to divide out operations vs board approved policies for the February BOC meeting.

Chief Palmer will get the index so the board can see the 160+ policies.

**Ada County Annual Dispatch Agreement** –There was a discrepancy with charged calls that needed to be amended. Chief will have a revised invoice and an updated agreement at the February BOC meeting.

Joint Powers Agreement – Star Fire Protection District, District Administrator Services – Comm. Crawford made a motion to approve resolution 2019-01 for the Interagency Contract for Administrative Services only with Star Fire Protection District and that Krystal Hinkle will be the administrator of the impact fees. Comm. Smith seconded the motion, motion passed with a unanimous voice vote.

Consider Resolution to adopt Intergovernmental Agreement with Ada Co. – Impact Fees – Tabled until February due to lack of communication from Ada County.

Attorney Gigray reported that he has been in contact with Anne Wescott to see if she can setup a meeting with the Ada County Commissioners. Bud Beatty mentioned that there is an ACCESS meeting next week and he and the Chief will bring it up to hopefully move the process along.

#### Consider Resolution to amend fee schedule – Impact Fees –

Comm. Smith made a motion to approve resolution 2019-02 that would amend the fee schedule by the addition of Development Impact Fess, direction for Secretary and Treasurer and the effective date. Comm. Humphrey seconded the motion, motion passed with a unanimous voice vote.

#### **New Business:**

## Consider Resolution to approve the amendment to Section 1 of Chapter 3 Title 20 –

Comm. Smith made a motion to approve resolution 2019-03 that would designate the Fire District Development Impact Fee Capital Trust Fund and Impact Fee records as permanently and indefinitely retained records and directs the secretary and attorney to establish an effective date. Comm. Engelhardt-Vogel seconded the motion, motion passed with a unanimous voice vote.

## Discuss and approve resolution Subrecipient/Beneficiary Grant Agreement -

Comm. Smith made a motion to approve resolution 2019-04 that would authorize the Chairman to sign the Subrecipient/Beneficiary Agreement with Ada County for proper equipment for hostile situations or active shooters. Comm. Crawford seconded the motion, motion passed with a unanimous voice vote.

**Discuss and approve resolution for an agreement with First Data Merchant Services** – The administrative staff has been approached by many customers about being able to pay with a card. Shannon has contacted many companies and First Data Merchant Services has the best rates for our customers.

Comm. Smith made a motion to approve resolution 2019-05 that would authorize the Chairman to sign an agreement with First Data Merchant Services to accept credit card payments for ambulance billing. Comm. Engelhardt-Vogel seconded the motion, motion passed with a unanimous voice vote.

## Station Lighting Proposals –

Chief Palmer reported that we don't the final figures so far. We have budgeted \$20,000.00 for the lighting upgrade and without the incentives included is \$10,800.00 but confident we will be under \$10,000.00 after everything is said and done. Idaho Power gave us an estimated savings of \$3500.00 annually once the upgrade is complete.

Comm. Smith said he had this completed at his place of business and the process was easy and didn't cost him anything. Chief Palmer will get the contacts name from Comm. Smith and have additional information in February.

## Ambulance Hardship Cases -

Krystal Hinkle presented Hardship Case #19-01 and #19-02. Case #19-01 met the qualifications for a 100% write off of the remaining balance of \$250.00. Case #19-02 met the qualifications for a 60% write off of \$495.48, with a balance of \$330.32.

Comm. Smith made a motion to purchase the AD&D policy for all employees, volunteers and Commissioners of the Kuna Rural Fire District through the Idaho State Fire Commissioners' Association. Comm. Engelhardt-Vogel seconded the motion, motion passed with a unanimous voice vote.

Comm. Engelhardt-Vogel moved to adjourn the meeting, Comm. Smith seconded the motion, motion passed with a unanimous voice vote.
