Comm. Smith moved to schedule a public hearing to consider the petition on July 11, 2018, 7:00 p.m. and to authorize the publication of the hearing. Comm. Humphrey seconded the motion, motion passed with a unanimous voice vote.

Yard Maintenance Proposal: Chief Palmer reported that the City of Kuna is willing to provide yard maintenance as well as snow removal for a small fee. Attorney Gigray advised that this could be done with a joint powers agreement with the City. He and the Chief will work on for the July meeting.

Surplus Property – John Deer Mower: Chief requested that the John Deer Lawn Mower be considered as surplus with an estimated value of \$500 or less.

Comm. Smith moved to donate the John Deer Lawn Mower to the Kuna Emergency Services Association to raffle off or sell to raise funds for the Association. Comm. Humphrey seconded the motion, motion passed with a unanimous voice vote.

Formation of Tax Levy Review Committee and Establish a Ballot Date: Chairman Beatty requested that this item be postponed until after the Executive Session.

Executive Session: Comm. Crawford moved to convene into Executive Session pursuant to Idaho Code Section 74-206 (1) (f) to consider and advise it's legal representative in pending litigation or where there is a general public awareness of probable litigation. Comm. Humphrey seconded the motion. Attorney Gigray, Chief Palmer and Robin Ward were asked to remain in the session. A roll call vote was taken and the motion passed unanimously. Commissioners convened into Executive Session at 8:15 p.m.
