Chief Report – Perry Palmer: Chief Palmer reported on the following:

- Station 2 completely cleaned out and keys have been given to Falcon Crest
- New Volunteers/Paid on Call Chiefs are planning to hold a graduation ceremony at the March meeting for the cadets that are completing the Firefighter I academy.
- New Full Time Firefighters Plan to have a pinning ceremony at the March meeting for the two new hires.
- Tenzinga Training Chiefs and Captains recently completed leadership training to implement Tenzinga which is an employee performance evaluation program that provides ongoing employee evaluations throughout the year.
- Kuna Butte Fire on February 10th
- Brush 62 is currently being painted red.
